**Note:**

Use of other park amenities for events, including but not limited to: grass areas for bounce houses, volleyball nets, tents, fences, gate access, or vehicle access are subject to additional fees, which will be determined by the event size, type and impact.

All uses and events held on property owned or managed by Douglas County Parks and Trails must be approved by the County prior to any use. Approval shall be in the form of a park permit and are subject to current park reservation fees. Family and recreational use of parks are exempt from this rule provided a fee is not charged and the activity is not regularly scheduled and ongoing.

Exercise Camps only include fitness-related activities that last no longer than two hours, and involve fewer than 30 participants. Any activity not meeting such criteria may not qualify for an Exercise Camp rate.
